The Port of Rotterdam Authority is working on a new system for inland port dues, which will replace the current web portal per 1 January 2023. With this system you will pay according to use and the Port of Rotterdam Authority will modernize the digital collection of inland port dues and make it more user-friendly. With this information flyer we like to inform you about the developments on a regular basis.

To ensure a right design of the new Inland Port Dues System we would like to test the system with you as a user. That's why we cordially invite you to participate in our next test phase starting on April 11 so that we can take your user experiences and feedback into account as best we can.

The programme team for the new system for inland port dues is currently concentrating on the following aspects:

1. The new tariff structure

The tariff policy being developed for the new system by the Port of Rotterdam Authority is based on payment according to use. The team is currently analyzing the underlying calculation rules and formulas to be used. In March we can give more clarity about the tariffs for using services in the port of Rotterdam. The new tariffs will be subject to tests being scheduled for the second quarter.

2. The legal aspect

The introduction of a new system also requires new general terms and conditions and various other rules and arrangements from a legal perspective. These include special provisions on environmental differentiation, for instance, as well as a policy framework concerning the use of the Automatic Identification System (AIS) and compliance with the GDPR. The idea is that by means of the AIS — and with the skipper's (the 'person concerned') approval — the data required is submitted fully automatically. This calls for a proper delineation of privacy-related matters. Submitting the data manually will also remain possible. 3. Technical developments and processes

Setting up the new system requires a great deal of time and attention to ensure that all

processes run smoothly. The team is focusing on automatic registration of visits at a berth level on the basis of AIS and GPS (barges). All links to these sources need to be implemented correctly, so that the proper data is entered in the system for invoicing. The feedback we received during the Proof of Concept in September 2021 is scrutinised and processed in the system setup. In the next test phase, this will allow us to establish whether the system meets the users' wishes.
